- Students have the opportunity to participate in the **Bar Fundamental Track** or **Concentration Track**. The former enables them to focus their studies and course selection on U.S. bar exam preparation while the concentration track provides specialized study in:
 - Corporate Law, Commercial Law and Trade;
 - Criminal Law;
 - Intellectual Property & Technology Law;
 - International and Comparative Law;
 - Justice, Democracy, and Legal Rights;
 - Regulation, Sustainability, and Compliance.
- LLM students are encouraged to participate in a variety of activities that will prepare them for legal practice, including clinics, competitions, trial advocacy, student organizations, pro bono, and over 100 lectures and events.

Flexible LLM Program

Spring or Fall Start:

Most students begin the program in the fall semester (August). Limited applications are accepted to begin in the spring semester (January).

2 or 3 Semester Option:

Students may elect to complete the LLM program in 2 or 3 semesters. This allows students the flexibility to customize a program of study, enjoy greater internship opportunities, and benefit from more time to study for the bar exam.

Application Requirements

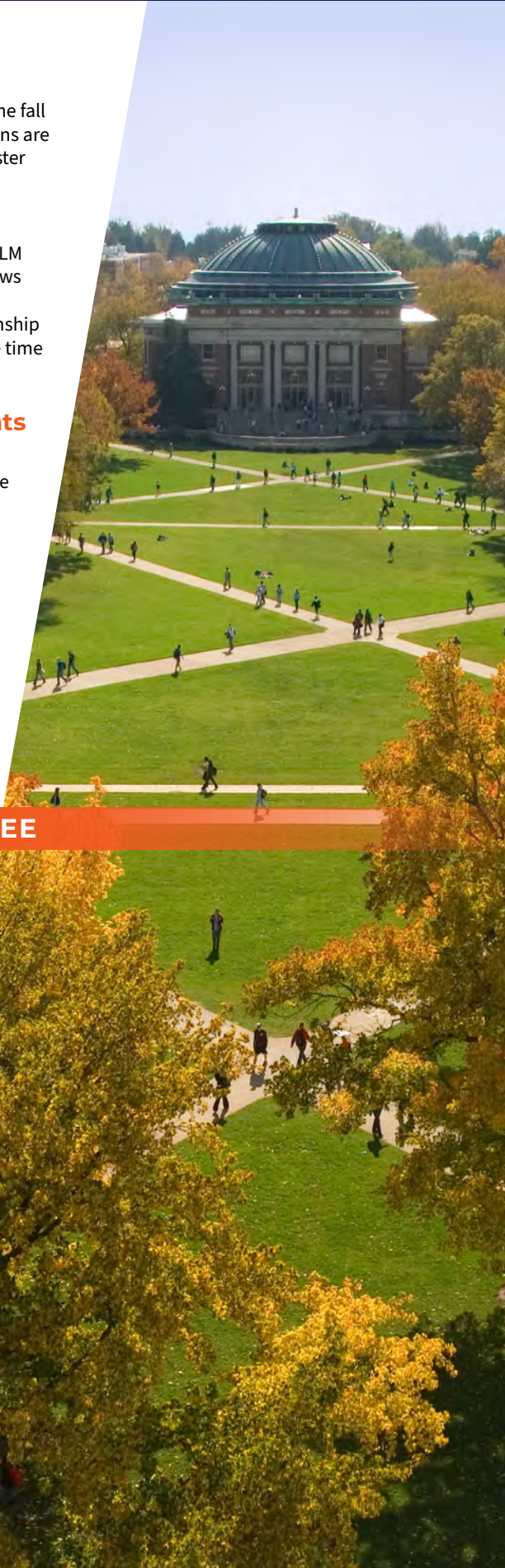
Applicants must hold a bachelor's degree, LLB, or equivalent degree. The bachelor's degree need not be in law. Application requirements include:

- Completed application

- Statement of purpose
- Certified transcripts and credentials
- At least one letter of reference
- TOEFL or IELTS or Duolingo score
- Copy of passport page
