Language Requirements	Students from universities where the language of instruction is not English must submit proof of English fluency. Official scores from TOEFL and IELTS test are accepted. Strongly preferred scores are 90 for iBT TOEFL and 7.0 for IELTS. If the only score a student has available is from a Cambridge Test, they should contact our office.
Application Procedure	<p>Partner Universities must first nominate students who are eligible for our LL.M. Program. Please email nominated student names and contact information to llmadmissions@uclawsf.edu by March 1, 2025. If you need more time to nominate candidates, please email the LLM Admissions Team at llmadmissions@uclawsf.edu.</p> <p>Upon receiving the nomination, the UC Law SF LL.M. Admissions Office will contact nominated students directly with further instructions. Students must submit the following documents (unless otherwise stated in our exchange agreements):</p> <ul style="list-style-type: none"> • Official or Verified TOEFL/IELTS score or TOEFL Waiver Request • Official Transcript(s) • Two Letters of Recommendations • Personal Statement • Resume or CV
Student Application Deadline	Applications are accepted on a rolling basis. We encourage applicants to submit their applications early in order to receive their enrollment decision in a timely manner; however, we will continue to accept and review completed applications until April 30, 2025 .

Academic Requirements	LL.M. candidates are required to successfully complete at least 24 credit hours of classes over two semesters of study, beginning with the Fall semester. All LL.M. candidates must take Introduction to Law (Fall, 3 units), Legal Research & Writing for Masters Students (Fall, 2 units), and one of the following first-year required courses: Contracts, Torts, Criminal Law, Property, Constitutional Law, or Civil Procedure. LL.M. candidates may also take Constitutional Law II or Civil Procedure II to satisfy the first-year course requirement. In addition, LL.M. Candidates must attend and successfully complete a 2-week orientation program (1 unit) prior to the start of the Fall semester. Global Programs Advisors help students tailor their remaining courses to their own professional and personal interests.
Areas of Specialization	<p>Students may choose to specialize in one of 8 areas of specialization. Specializations are noted on students' UC Law SF transcripts upon consultation with a Global Programs Advisor and completion of at least 12 credits in an area of specialization. Our specialization areas are as follows:</p> <ul style="list-style-type: none"> • Criminal Law • Dispute Resolution and Legal Process • Environmental Law • Health Law and Policy • International Business and Trade • International Law and Human Rights • Science, Technology, and Intellectual Property • Taxation <p>Students who choose to participate in at least one legal clinic or the Startup Legal Garage and complete at least one of experiential learning courses will receive a Practice Training Certificate at graduation. Advance approval from the Associate Dean for Global Programs required to participate in this certificate track.</p>
Orientation Program (Mandatory)	All LL.M. candidates must attend a 2-week orientation program prior to the beginning of classes (August 4-15, 2025).
Semester Dates	Fall semester classes begin on August 18, 2025 and final exams will end on December 18, 2025. Spring semester classes begin on January 5, 2026 and final exams will end on May 8, 2026. The commencement ceremony is scheduled on May 11, 2026.
Course Enrollment/Registration	Students register for courses online. The Course List for Fall 2025 will become available in May 2025. The current academic year course descriptions may be found at https://www.uclawsf.edu/academics/course-catalog/ . Please note that certain courses, particularly seminars, may not be offered each year. All courses, with the exception of Introduction to Law and Legal Research & Writing for Masters Students, are taken together with UC Law SF Juris Doctor students.

<p>Housing</p>	<p>UC Law SF is one of the few graduate schools that offers on-campus housing to their students. Our new on-campus housing, the Academe at 198 (https://academe198sf.com/), opened in August 2023. All rooms are fully furnished. Community amenities include large lounges with skyline views, free WIFI, laundry facilities, a fitness center, an outdoor courtyard, bicycle storage, study rooms, communal kitchens, and entertainment rooms. Units are assigned on a first-come, first-served basis after enrollment deposits are paid. (Students are responsible for paying rent.)</p>
<p>Immigration Information</p>	<p>Students who are not U.S. citizens or legal U.S. permanent residents must apply for and obtain F-1 student status at a U.S. embassy/consulate prior to participating in the LL.M. Program. Students who need an F-1 student visa must submit the following documents in addition to the required application documents listed in the "Application Procedure" section above after they are officially admitted and submit their non-refundable enrollment deposit:</p> <ul style="list-style-type: none"> • Completed Certificate of Financial Resources • Documentation of resources to show that a student and/or a student's sponsors have sufficient funds to cover the student's living costs and other expenses (bank statements, letter of sponsorship, etc.) • Dependent Form (if the student is bringing dependents) • A copy of the student's passport's biographic page <p>Students may be eligible to apply for a J-1 Exchange Visitor visa. <p>Health Insurance Requirements</p>	<p>The University of California and UC Law SF require all enrolled students to have health insurance coverage that meets University of California minimum requirements. All students are automatically enrolled in, and billed for, the University of California Student Health Insurance Plan (UCSHIP) for graduate students. Estimated insurance premiums for the 2024-25 academic year are U.S.\$ \$2,746 -3,844 PER SEMESTER.</p> <p>Students who have another insurance policy that meets and/or exceeds University of California minimum requirements may apply for a health insurance waiver. Information on health insurance for the current 2024-25 academic year is available at https://www.uclawsf.edu/campus-life/student-health-services/uc-ship/. The information will be updated in April 2026 for the 2025-26 academic year.</p> <p>Final UCSHIP premium costs and information on the health insurance waiver process will be sent to admitted students the summer prior to their program start date.</p> <p>PLEASE NOTE THAT COVERAGE UNDER SOME FOREIGN HEALTH INSURANCE PLANS MAY NOT SATISFY THE MINIMUM UC REQUIREMENTS. IF A STUDENT APPLIES FOR A WAIVER AND THE WAIVER IS DENIED, THE STUDENT WILL BE BILLED FOR UCSHIP. NO EXCEPTIONS CAN BE MADE TO THIS REQUIREMENT. STUDENTS SHOULD BE SURE THAT THEY ARE COMFORTABLE WITH THE UC LAW SF HEALTH INSURANCE REQUIREMENTS BEFORE PARTICIPATING IN THE PROGRAM.</p>

<p>U.S. Bar Information</p>	<p>Students who are already practicing lawyers in their home jurisdictions can apply to sit for the bar examination of many states in the U.S.</p> <p>Students who are not admitted to the bar in their own country, but have a first degree in law from a country outside of the United States may apply to sit for a bar exam in the United States if they have the required number of years of study.</p> <p>In California, this means that in addition to an LL.B. degree, students must have been awarded an LL.M. degree from an ABA accredited law school with a minimum of 20 credits of legal education. Students must also have taken at least 12 credits of courses related to subjects tested on the California bar exam, including Professional Responsibility. For more information on bar exam eligibility, students should consult the California State Bar Examiners Rules for qualifying to take the bar exam at https://www.calbar.ca.gov/Admissions/Requirements/Education/Legal-Education/Foreign-Education.</p> <p>The requirements for taking the New York Bar Exam are similar to those of California, but not the same.
