## "The Changing Nature of Peace and Security" Seminar (096925)

## Summer Semester 2023

The United Nations, founded in 1945, today has 193 Member States. Tasked with the maintenance of international peace and security, the Security Council of the United Nations plays a prominent role in the United Nations as system of collective security. It is the Security Council's responsibility to react to international crises by either peaceful means (Chapter VI of the UN-Charter) or even forceful measures (Chapter VI of the UN-Charter), once it has determined a breach or threat to peace and security.

This class takes a closer look at Chapter VII and especially Article 39 of the UN-Charter. It asks if the content and meaning of "international peace and security" has changed over the years, especially in light of the growing influence of international human rights. Is peace just the absence of war or are there more elements to take into consideration? How does the Security Council define "international peace and security" and a breach or threat thereof? As the determination of the Security Council of a situation as breach or threat to peace and security leads to wide-ranging competences according to Chapter VII of the UN-Charter, the aforementioned question is of crucial importance. At the same time the questions arise: what if the Council does not act, f.e. because of the blockade by a veto-holding member; or: who controls the decisions of the Council?

The class will start with introductory classes on the United Nations, the Security Council, and Chapter VII of the Charter of the United Nations. Participants are expected to choose from one of the following topics (max. two persons per topic = team work!), prepare a 6-8 page summary (plus bibliography) on the subject and present it to the class via Powerpoint (or other) Presentation. Also, they are asked to take over a commentary for a different topic. The class will be held in <u>English</u> on <u>Thursdays, 14.00 – 16.00 h (c.t.)</u>. Successful participants will receive 5 ECTS-credits and a "Proof of Legal Language Skills in English" pursuant to § 8 para. 2 of the study regulations for the study of law with the first legal examination of 25 March 2015 – *Fremdsprachenfachkompetenz*. The final grade will be determined according to the summary paper (1/3), the presentation (1/3), additional points can be achieved through an active participation in the discussions and the commentary (1/3).
